Significance

Statement Of Significance

For the Aboriginal and non-Aboriginal communities the site is a landmark in the hisotry of black-white relations in Australia. For Aboriginal people in particular it represents a key historical site symbolising dispossession, child removal and enduring links to land.

For Darug people it represents a physical, tangible link with the pre-colonial landscape and holds memories of historical events and attitudes passed down to them by relatives. Its physical form evokes memories associated with experiences of the place including fishing, camping, swimming and of eth archaeological remains of the school and its setting. The site provides an enduring link with traditional land from before colonsisation to the present.

The local non-indigenous community holds this site in high esteem because of its association with important historical events, processes and individuals; as an origin point for the community of Blacktown; because of its archaeological importance; and because of its importance to the Aboriginal community.

The site is also of importance to the Sydney Maroi commuity as an early tangible link with the colonial history of trans-Tasman cultural relations and with the history of children removed by missionaries.

The site has the potential to yield rar archaeological information through excavation and research. In particular, this information would relate to eth indigenous experience of life in an around the Institution whiech would provide a counterpoint and contrast to the historical records of the period.

The history of this site involves some of the most influential individuals in colonia history including Lachlan and Mrs Macquarie, Samuel Marsden, and the Anglican and Wesleyan missionaries. It also involves indigenous periopl: Nurrangingy, who received the first land garant to an indigenous person under colonial administration: Maria Lock, a pupil of the school and long term Blacktown resident; as well as their families and the Aboriginal community which, despite dispossession, has been maintained in this area. Historical Notes or Provenance

In the late nineteenth and early twentieth century, many Europeans argued that all humankind was equal and that indigenous people needed only to be educated to be equal to whites. Governor Macquarie had been instructed to 'conciliate the affection of the Aborigines and to prescribe that British subjects live in amity and kindness with them.' Rev. Samuel Marsden had also been advised that he should 'contribute to the civilisation of the Heathen and thus prepare them for the reception of moral and religious instruction.'

As well as this background, settlers in the Hawkesbury district were facing increasing conflicts with the dispossessed Darug people. In 1814, William Shelley proposed a public establishment for educating Aboriginal children. Macquarie agreed to the idea, resolving to 'make an Experiment' by establishing a 'Black native Institution of NSW' to be managed by Shelley.

The school was opened at Parramatta in January 1815. Aborigines resisted letting their children be taken away to the institution. Others did not recognise their decision to let the children be taken to the school as a permanent arrangement.

A second native institution was established near the present day intersection of Rooty Hill Road North and Richmond Road in 1823 and ran until 1829. This later institution was a two storey building with two large rooms downstairs, four small bedrooms, two outside rooms, a verandah, separate kitchen, stable and coach house. Problems arose including constant fears of theft due to the isolated location and children running away from the place. Governor Brisbane closed the institution at the end of 1824 and it was abandoned in 1825. By 1826 it was decided to repair the building and in 1827 the school was re-opened. In 1829 the school was closed for the last time and the children were transferred to Cartwright at Liverpool.

As well as taking indigenous children, the institution also took in Maori children hoping to 'civilise' this group as well.

The Reserve was sold in 1833. By 1880 the remaining house was known as Lloydhurst. This burnt down in 1924. In the 1940s a house was built on the footings of the Native Institution. This house has since been demolished.
