Significance

Statement Of Significance

Located close to Castlereagh Road and set against the backdrop of the Blue Mountains, this weatherboard cottage eloquently defines the rural character of the area and demonstrates the longevity of European settlement in Castlereagh. Albeit relocated c.1950s the building is one of a small number of extant rural structures on Castlereagh Road erected over the nineteenth century which collectively demonstrate the pattern of rural settlement at Castlereagh and imbue the area with its high historic and aesthetic values.

The cottage demonstrates the longevity of European settlement in Castlereagh

Aesthetic/Technical Significance

Located close to Castlereagh Road and set against the backdrop of the Blue Mountains, the cottage contributes to defining the rural character of the area.
